

The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Commissioner of Insurance:

1. Respondent shall cease and desist from offering to unlicensed individuals payment or other incentives for referrals that result in the sale of insurance.

2. Respondent shall pay an administrative penalty in the amount of two hundred fifty dollars (\$250.00), payable within thirty (30) days of the date of this Final Order.

AGREED ENTRY

This Agreed Entry is entered into by Nikolas P. Mann, Attorney for and on behalf of the State of Indiana, Department of Insurance ("Department"), and Julie A. Holt, ("Respondent"), a licensed Indiana non-resident insurance producer, to resolve all matters in the administrative action commenced by the Department. This Agreed Entry is subject to the review and approval of James Atterholt, Commissioner for the Indiana Department of Insurance.

WHEREAS, Respondent is a licensed non-resident insurance producer in the State of Indiana, holding license number 573552; and,

WHEREAS, the Department commenced an investigation of Respondent after receipt of information that Respondent had offered unlicensed individuals prepaid gas cards for client referrals resulting in the sale of an insurance policy; and,

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without the necessity of an administrative hearing.

IT IS THEREFORE NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and the

Respondent in this administrative action.


2. ~~yes~~ This Agreed Entry is executed voluntarily by the parties. Respondent voluntarily and freely waives her right to a public hearing on this matter.
3. Respondent voluntarily and freely waives her right to petition for judicial review of this agreement and the Commissioner's Final Order.
4. Respondent agrees to cease and desist from the practice of offering incentives to unlicensed individuals for only the referrals that result in a sale.
5. Respondent agrees to pay an administrative fine in the amount of two hundred fifty dollars (\$250.00), payable within thirty (30) days from the date the Commissioner signs the Final Order in this matter.
6. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.
7. Respondent is aware that failure to comply with any terms of this agreement will result in the matter being set for hearing.
8. Respondent has carefully read this agreement and fully understands and accepts its terms.
