WHEREAS, Respondent is a licensed resident insurance agent in the State of Indiana; and

WHEREAS, on or about February 17, 2009, a formal notice of cancelation of contract for cause was received by the Department from Keisha Weeks, the Market Conduct/Regulatory Compliance Director for AFLAC Insurance Company, alleging that the Respondent knowingly submitted applications with false information, created bogus

applications, and manufacturing 78 policies on 32 fabricated policy holders. The alleged exposure to the company was \$14,735.24, paid in commissions;

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and the respondent in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives his right to a public hearing on the issues in this action.
- 4. Respondent admitted to Department investigator Mike Herndon that he misrepresented the terms of proposed applications for insurance by manufacturing false policies because of the enormous pressure to sell.
- 5. Respondent committed fraud in the business of insurance by intentionally misrepresenting the terms of proposed insurance applications for insurance.
- 6. Respondent used fraudulent and dishonest practices, demonstrating untrustworthiness in the conduct of business in Indiana.
- 7. Respondent agrees to the permanent revocation of his Indiana resident insurance producer license number 377702.
- 8. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.
- 9. Respondent has carefully read this agreement and fully understands and accepts its terms.
