FINAL ORDER

On September 3, 2009, the appointed Administrative Law Judge, John R. Kissling, Jr., filed his Findings of Fact, Conclusions of Law, and Recommended Order in the above-captioned matter.

1. The Department served Findings of Fact, Conclusions of Law, and Recommended Order and Notice of Filing of Recommended Order on Respondent by mailing the same to his home address of record and to his attorney, Gary R. Brock.

2. The Department has complied with the notice requirements of Ind. Code § 4-21.5-3-17.

3. Respondent has not filed an objection with the Commissioner regarding the Administrative Law Judge's Recommended Order, and more than eighteen (18) days have elapsed.

THEREFORE, the Commissioner of Insurance, being fully advised, now hereby adopts in full the Administrative Law Judge's Findings of Fact, Conclusions of Law, and Recommended Order, and issues the following Final Order:


IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Commissioner of Insurance:

1. Respondent's insurance producer license, #3015890, is hereby immediately and permanently revoked.

2. Respondent shall pay a fine in the amount of five thousand dollars (\$5,000.00) for not complying with the Final Order of December 23, 2008 in addition to the one thousand dollar (\$1,000.00) fine imposed by the Final Order of December 23, 2008. The total fine is six thousand dollars (\$6,000.00) and is due in full within sixty (60) days after the date of this Final Order.

Under Ind. Code § 4-21.5-5-5, Respondent has the right to appeal this Final Order by filing a petition for judicial review in the appropriate court within thirty (30) days.
