- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent shall pay an administrative fine in the amount of \$1,500.00 within thirty (30) days of the filing of a Final Order adopting this Agreed Entry.
- 6. Respondent has carefully read this agreement and fully understands and accepts its terms.
