

3. Respondent will pay an Administrative Fine in the sum of One Thousand Two Hundred and Fifty Dollars (\$1,250.00). The fine is to be paid within 30 days of this Commissioner's Final Order.

WHEREAS, Respondent is a licensed resident insurance agent in the State of Indiana, operating under License Number 1446190, and

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing or the necessity of the filing of a statement of charges;

IT IS THEREFORE, NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter of and the parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.

3. Respondent voluntarily and freely waives his right to a public hearing.
4. Respondent voluntarily and freely waives his right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Respondent failed to disclose a misdemeanor arrest in 1996 to the Department, in violation of Indiana Code § 27-1-15.6-17(b).
6. Respondent failed to disclose a felony arrest in 2007 to the Department, in violation of Indiana Code § 27-1-15.6-17(b).
7. Respondent allowed an unlicensed employee to solicit or negotiate insurance in violation of Indiana Code § 27-1-15.6-12(b)(7).
8. Respondent states that he was unaware of the employee's activities.
9. Respondent agrees to pay an Administrative Fine in the sum of One Thousand Two Hundred and Fifty Dollars (\$1,250.00). The fine is to be paid within 30 days of the Commissioner's Final Order.
10. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's producer license.
11. Respondent has carefully read and examined this agreement and fully understands its terms.

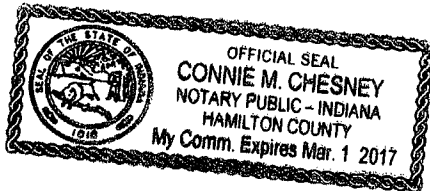
