AGREED ENTRY

This Agreed Entry is subject to the review and approval of Carol Cutter, Commissioner of the Indiana Department of Insurance.

WHEREAS, during the course of a regular agency examination it was discovered that Respondent was an unlicensed agency which was selling soliciting or negotiating title insurance in the State of Indiana;

WHEREAS, Respondent obtained the proper license and was engaged in the business of selling, soliciting or negotiating title insurance in the state of Indiana;

WHEREAS, Respondent has since ceased conducting business in the name of Bolly Title, LLC and license number 624806 has been cancelled;

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Respondent in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- Respondent knowingly, voluntarily and freely waives its right to a public hearing on the issues in this action.
- 4. Respondent waives its right for a judicial review of this matter.
- Respondent acknowledges that it has engaged in the selling, soliciting and
 negotiating of title insurance without a valid Indiana insurance producer license.
- 6. Respondent also acknowledges that selling soliciting or negotiating any form of insurance in the State of Indiana without a valid insurance producer license violates Indiana Code 27-1-15.6-3, which states, "(a) A person shall not sell, solicit, or negotiate insurance in Indiana for any class or classes of insurance unless the person is licensed for the line of authority under this chapter" and is subject to Indiana Code 27-1-2-4, which states, "A person who recklessly violates the Indiana Insurance Law (chapters 2 through 20 of this article) commits a Class A misdemeanor, except as otherwise provided."
- 7. Respondent agrees to pay a civil penalty of \$883.00 and within twenty (20) days of the signing of the Commissioner's Final Order for non-compliance with the Indiana insurance producer licensing statutes.
