

3. Respondent voluntarily and freely waives his right to a public hearing.
4. Respondent voluntarily and freely waives his right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Respondent improperly withheld, misappropriated, or converted money received in the course of doing insurance business.
6. Respondent's conduct is in violation of Indiana Code 27-1-15.6-12(b)(4).
7. Respondent agrees that his Indiana producer license, number 2819620, will be permanently revoked.
8. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's producer license.
9. Respondent has carefully read and examined this agreement and fully understands its terms.



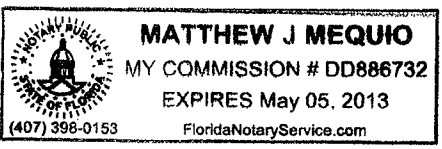
