FINAL ORDER

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent provided incorrect, misleading, incomplete, or materially untrue information in a license application.
2. Respondent’s conduct was in violation of Indiana Code § 27-1-15.6-12(b)(1).
3. Respondent will pay an Administrative fine of Two Hundred and Fifty Dollars (\$250.00) within thirty (30) days of this Commissioner’s Final Order.

WHEREAS, Respondent is a licensed non-resident insurance producer, holding license number 655656; and


WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing or the necessity of the filing of a statement of charges;

1. The Commissioner has jurisdiction over the subject matter of, and the parties to, this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.


3. Respondent voluntarily and freely waives her right to a public hearing.
4. Respondent voluntarily and freely waives her right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Respondent failed to disclose a misdemeanor criminal conviction on her application for an Indiana producer license.
6. Respondent provided incorrect, misleading, incomplete, or materially untrue information in a license application.
7. Respondent's conduct was in violation of Indiana Code § 27-1-15.6-12(b)(1).
8. Respondent will pay an Administrative fine of Two Hundred and Fifty Dollars (\$250.00) within thirty (30) days of the Commissioner's Final Order.
9. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's producer license.
10. Respondent has carefully read and examined this agreement and fully understands its terms.

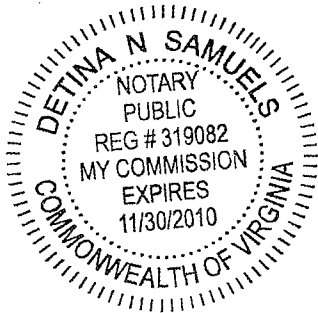
