ADMINISTRATIVE ORDER
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to the Indiana Administrative Act, Indiana Code 4-21.5-1 et seq. and Indiana Code § 27-1-15.6-12, hereby gives notice to Trevor Hensley, (“Respondent”) of the following Administrative Order:

1. Indiana Code § 27-1-15.6-12(b) provides that “The commissioner may levy a civil penalty, place an insurance producer on probation, suspend an insurance producer’s license, revoke and insurance producer’s license for a period of years, permanently revoke an insurance producer’s license, or refuse to issue or renew an insurance producer license, or take any combination of these actions, ...”

2. Indiana Code § 27-1-15.6-12(d) provides that when the Commissioner refuses to renew a license, the Commissioner shall notify the Respondent, in writing, of the reasons for the nonrenewal.

3. Respondent, a resident of Ohio, holds producer’s license number 644177.

4. The Department was notified that Respondent's application for a producer's license was denied in the state of Missouri in October, 2009.

5. Further investigation revealed that similar license applications were denied in the states of Michigan, Arkansas and Louisiana.

6. Respondent failed to report these administrative actions to the Department as required by Indiana Code § 27-1-15.6-17.

7. The Department has attempted to contact Respondent to discuss these violations of Indiana Code.

8. The Department attempted to contact Respondent by certified mail, but the article was returned by the United States Postal Service because Respondent had moved to 27645 Bishop Park Dr., Apt 321, Willoughby Hills, Ohio 44092.

9. The Department sent an additional letter by certified mail to the Bishop Park Dr. address. The letter was returned the Department as unclaimed.

10. Respondent failed to notify the Department of the change in address as required by Indiana Code § 27-1-15.6-7 (h).

11. Respondent's conduct, as alleged herein, is cause for disciplinary action in accordance with Indiana Code § 27-1-15.6-12 (b) (8), § 27-1-15.6-17, and § 27-1-15.6-7 (h)..

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **Respondent's license shall not be renewed.**

WHEREFORE, the Commissioner further notifies Respondent that pursuant to Indiana Code §27-1-15.6-12(d), within sixty (60) days of receiving this Notice, Respondent may make a written demand upon the Commissioner for a hearing to determine the reasonableness of this

action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.
