WHEREAS, Respondent is a licensed resident insurance agent in the State of Indiana; and

WHEREAS, on or about October 27, 2009, a formal notification of termination of appointment was received by the Department from Bob Nelson, the licensing supervisor for State Farm Insurance Companies, alleging that the Respondent knowingly produced false loan documents and provided false rate information in conjunction with loans

booked through State Farm Bank. As a result, State Farm Bank may be required to honor the rates provided to customers by Respondent and is likely to suffer a financial loss;

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and the respondent in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives his right to a public hearing on the issues in this action.
- 4. Respondent admitted to State Farm Bank Investigator Russell Ruestman that he drafted and provided to State Farm Banking Agent Todd Thomae and State Farm Bank customer Richard Schultze a fictitious email, for the purpose of deceiving Agent Thomae and Richard Schultze. Respondent admitted that he drafted and provided customer Richard Schultze with a fictitious State Farm Bank Promissory Note, for the purpose of deceiving Richard Schultze. Respondent admitted that he drafted and provided customer Mark Hartig with an e-mail, with false rate information. Respondent also admitted to drafting and providing customer Elias Kalafatis with a fictitious State Farm Bank Promissory Note for the purpose of deceiving Elias Kalafatis.

- 5. Respondent used fraudulent and dishonest practices, demonstrating untrustworthiness, and financial irresponsibility in the conduct of business in Indiana.
- 6. Respondent agrees to the permanent revocation of his Indiana resident insurance producer license number 510313.
- 7. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.
- 8. Respondent has carefully read this agreement, consulted with counsel and fully understands and accepts its terms.
