

**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, on October 17, 2008, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Candice Spears ("Respondent") a certified letter requesting a list of appointments and a written response to a complaint received by the Department.

WHEREAS, on January 5, 2009, certified mail article # 7004 1160 0000 3843 2104 was returned as "unclaimed" by Respondent.

WHEREAS, on April 16, 2009, the Commissioner mailed a second request and a copy of the complaint to the Respondent via first class mail. To date, the item has not been returned.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as requested by the Commissioner.


WHEREAS, Respondent's failure to provide said list constitutes a violation of IC 27-1-15.6-12(g).

WHEREAS, the Commissioner has the authority to issue an order suspending Respondent's license without a hearing pending receipt of said list of appointments pursuant to IC 27-1-15.6-12(g).

WHEREAS, the Commissioner shall set this matter for hearing upon request of Respondent pursuant to IC 4-21.5-4-4.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 511223 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments and response requested by the Commissioner.
