FINAL ORDER



The Commissioner hereby incorporates the Agreed Entry as if fully set forth as attached as Exhibit A herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent improperly withheld commissions payable to another agent in violation of Indiana Code § 27-1-15.6-12(b)(4).
2. Respondent will pay an Administrative fine of Two Hundred and Fifty Dollars (\$250.00) within thirty (30) days of this Commissioner’s Final Order.

WHEREAS, Respondent Kathy A. Rader-Rodenberger is a resident licensed insurance producer, holding license number 2529070; and


WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing or the necessity of the filing of a statement of charges;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter of, and the parties to, this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.

3. Respondent voluntarily and freely waives her right to a public hearing.
4. Respondent voluntarily and freely waives her right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Respondent was the subject of a complaint by an Indiana resident producer.
6. Respondent improperly withheld commissions payable to another agent, Ken Collins. Mr. Collins successfully filed suit against the Respondent in Wabash Superior Court under cause number 85D01-0911-SC890.
7. Respondent's conduct was in violation of Indiana Code § 27-1-15.6-12(b)(4).
8. Respondent will pay an Administrative fine of Two Hundred and Fifty Dollars (\$250.00) within thirty (30) days of the Commissioner's Final Order.
9. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's producer license.
10. Respondent has carefully read and examined this agreement and fully understands its terms.
