

AGREED ENTRY

This Agreed Entry is executed by Standard Security Life Insurance Company of New York ("Standard"), VIMO, Inc. ("VIMO"), David Jason Landers ("Landers") and Nikolas P. Mann, Attorney, Deputy Commissioner, Enforcement Division for the Indiana Department of Insurance (the "Department") to resolve all issues in the above cause number. This Agreed Entry is subject to the review and approval of Doug Webber, Acting Commissioner of the Indiana Department of Insurance.

WHEREAS, Respondent Standard Security Life Insurance Company of New York is a New York domiciled insurance company with its principal place of business in New York, New York, and holds a Certificate of Authority in the State of Indiana; and,

WHEREAS, Respondent VIMO, Inc. is a corporation with its principal place of business in Mountain View, California, and is a licensed non-resident insurance producer in the State of Indiana, holding license number 38287; and,

WHEREAS, Respondent David Jason Landers is a licensed non-resident insurance producer in the State of Indiana, holding license number 698073; and,

WHEREAS, Respondent Standard accepted an health insurance application from Respondent VIMO that was solicited to an Indiana consumer by Respondent Landers prior to Respondent Landers being licensed in Indiana; and,

WHEREAS, the Department and Respondents desire to resolve their differences and settle the issues without the necessity of a hearing:

IT IS, THEREFORE, NOW AGREED by the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and the Respondents in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondents voluntarily and freely waive their right to a public hearing.
4. Respondents voluntarily and freely waive their right to judicial review of this matter.
5. Respondents agree to pay an administrative penalty in the amount of one thousand five

hundred dollars (\$1,500.00), payable within thirty (30) days of the Commissioner's Final Order in this matter.

6. The Department agrees to accept Respondents' compliance with the terms of this Agreed Entry as a full resolution of this matter.

7. Respondents have carefully read this Agreed Entry and fully understand and accept its terms.


