FINAL ORDER

The Indiana Department of Insurance (“Department”) and Michael J. Ball, a licensed resident insurance producer, signed an Agreed Entry which purports to resolve all issues involved in the action by the Department regarding Respondent’s license, and which has been submitted to the Commissioner of Insurance (the “Commissioner”) for approval.


The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth as attached as Exhibit A herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent failed to notify the Department of a criminal prosecution within thirty (30) days after an initial pretrial hearing date in violation of Indiana Code 27-1-15.6-17(b).

2. Respondent was convicted of Child Solicitation, a Class D Felony in violation of Indiana Code § 27-1-15.6-12(b)(6).
3. The Respondent's Indiana Producer License is permanently revoked.

WHEREAS, Respondent Michael J. Ball is a resident licensed insurance producer, holding license number 430813; and


WHEREAS, the Department filed a Statement of Charges against the Respondent on March 26, 2010, alleging that Respondent had failed to report a criminal prosecution, and a felony conviction in violation of Indiana Code; and

WHEREAS, the parties conversed prior to an administrative hearing for the purpose of negotiating a settlement of the issues in the Statement of Charges;


IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter of, and the parties to, this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives his right to a public hearing.
4. Respondent voluntarily and freely waives his right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Respondent failed to notify the Department of a criminal prosecution within thirty (30) days after an initial pretrial hearing date in violation of Indiana Code 27-1-15.6-17(b).
6. Respondent was convicted of Child Solicitation, a Class D Felony in violation of Indiana Code § 27-1-15.6-12(b)(6).
7. The Respondent's Indiana Producer License will be permanently revoked.
8. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's producer license.
9. Respondent has carefully read and examined this agreement and fully understands its terms.
