

3. Respondent provided incorrect, misleading, incomplete, or materially untrue information in a license application.
4. Respondent's Indiana resident producer's license, number 428124, is Permanently Revoked.

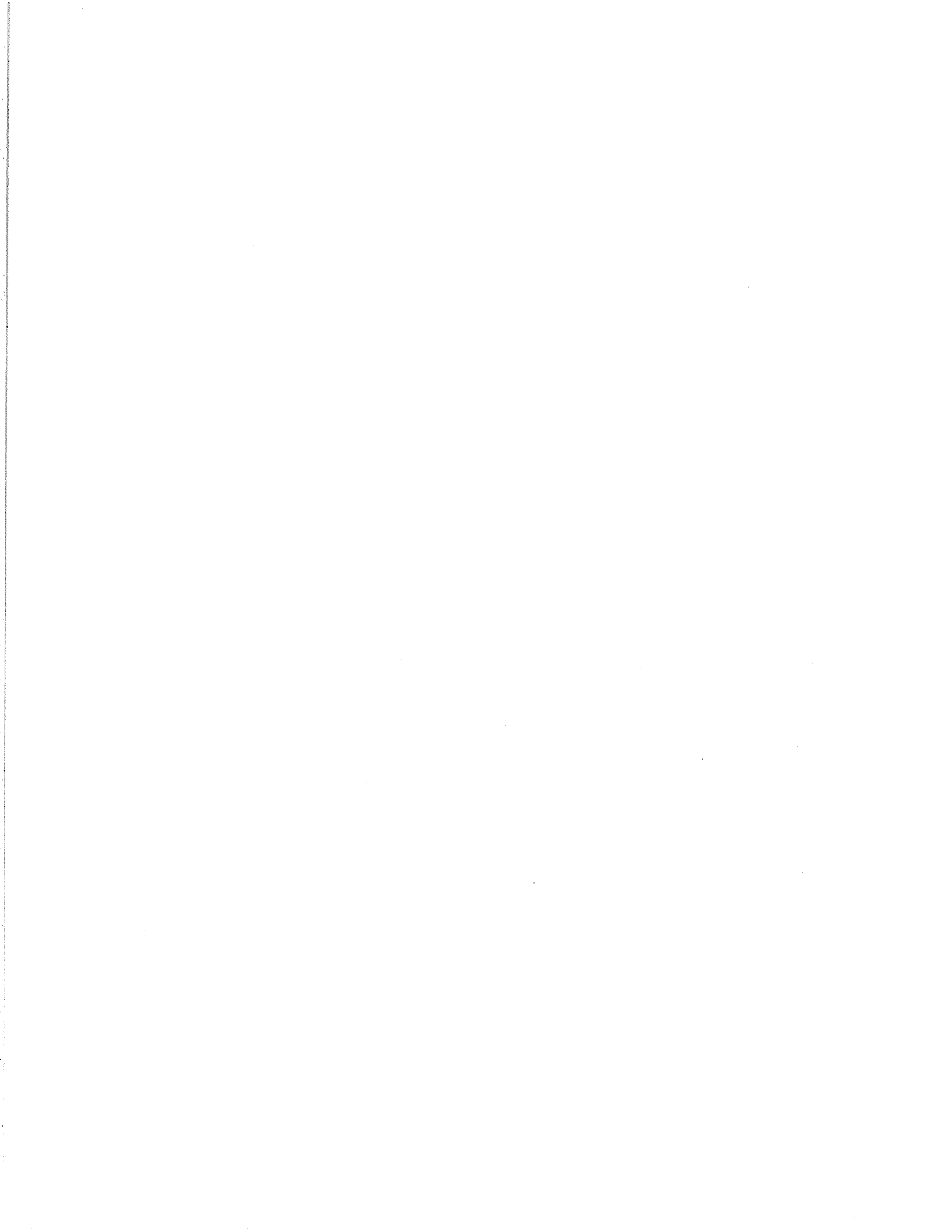

AGREED ENTRY

This Agreed Entry is entered into by Nikolas P. Mann, attorney for and on behalf of the State of Indiana, Department of Insurance (“Department”), and Aaron Michael Stroup (“Respondent”), a licensed Indiana resident insurance producer holding license number 428124, to resolve all matters under Cause Number 9370-AG10-0603-107. This Agreed Entry is subject to the review and approval of Doug Webber, Acting Commissioner, Indiana Department of Insurance.

WHEREAS, Respondent is a licensed resident insurance producer in the State of Indiana; and

WHEREAS, on May 19, 2010, the Department received a notice from General Insurance Agency, Inc. that the Respondent was recently found guilty of a felony; and

WHEREAS, on January 29, 2009, one (1) count of Burglary and one (1) count of Theft were filed against Respondent in the Wayne County Superior Court I; and

WHEREAS, on April 30, 2009, Respondent first appeared before the Wayne County Superior Court I for a pre-trial conference; and


WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;


IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives his right to a public hearing on the issues in this action.
4. Respondent has been convicted of two felonies.
5. Respondent failed to report to the Commissioner his criminal prosecution within thirty (30) days of his initial pretrial date, July 2, 2009.
4. Respondent failed to report to the Commissioner his prior criminal prosecutions in Allen and Elkhart Counties on his initial application.
5. Respondent agrees to the permanent revocation of his Indiana resident insurance producer license number 428124.
8. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.
9. Respondent has carefully read this agreement and fully understands and accepts its terms.
