

FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, on October 8, 2008, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Jeremy Theodore Rice ("Respondent") a certified letter requesting a list of company appointments and a notice of failure to notify the Department of an administrative action taken against his producer license in Alabama.

WHEREAS, on October 20, 2008, certified mail article # 7004 1160 0000 3843 2005, was delivered by the US Postal Service to the Respondent and signed for by agent for Respondent, Heather Rice.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as requested by the Commissioner.


WHEREAS, Respondent's failure to provide said list constitutes a violation of IC 27-1-15.6-12(g).

WHEREAS, the Commissioner has the authority to issue an order suspending Respondent's license without a hearing pending receipt of said list of appointments pursuant to IC 27-1-15.6-12(g).

WHEREAS, the Commissioner shall set this matter for hearing upon request of Respondent pursuant to IC 4-21.5-4-4.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 499507 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments and response requested by the Commissioner.
