1. Respondent Andrew S. Bures’ producer license is permanently revoked.
2. Respondent Bures & Associates, Inc.’s producer license is permanently revoked.

3. Respondent Bures Insurance Inc.'s producer license is permanently revoked.
4. Respondent Andrew S. Bures shall not in any way whatsoever take any part, or assume any role, in the ownership, operation or management of any insurance agency licensed to do business in the State of Indiana.

AGREED ENTRY

This Agreed Entry is executed by Nikolas P. Mann, attorney for and on behalf of the State of Indiana, Department of Insurance ("Department"), and Respondent Andrew S. Bures, a licensed resident insurance producer and the Qualifying Active Officer for Respondent Bures & Associates, Inc. and Respondent Bures Insurance, Inc. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Acting Commissioner/Executive Director of the Indiana Department of Insurance.

WHEREAS, Respondent Andrew S. Bures is a resident licensed insurance producer in the State of Indiana, holding license number 2098150; and

WHEREAS, Respondent Bures & Associates, Inc. is a resident licensed insurance producer in the State of Indiana, holding agency license number 563994; and

WHEREAS, Respondent Bures Insurance, Inc. was a resident licensed insurance producer in the State of Indiana, holding agency license number 2395160, before the license was cancelled effective January 28, 2008; and

WHEREAS, the Department filed a Statement of Charges against Respondents on April 20, 2010, alleging numerous violations of Indiana Code; and

WHEREAS, the parties conversed prior to an administrative hearing for the purpose of negotiating a settlement of the issues in the Statement of Charges; and


WHEREAS, Respondents have determined that it is financially impracticable for them to challenge the Statement of Charges,

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Acting Commissioner/Executive Director has jurisdiction over the subject matter of, and the parties to, this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondents voluntarily and freely waive their right to a public hearing.
4. Respondents voluntarily and freely waive their right to petition for judicial review of this Agreed Entry and the Acting Commissioner/Executive Director's Final Order.
5. Respondents neither admit nor deny the allegations set forth in the Department's Statement of Charges filed on April 20, 2010.
6. Respondent Andrew S. Bures, individually and on behalf of Respondents Bures & Associates, Inc. and Bures Insurance, Inc., agrees to the permanent revocation of insurance producer license numbers 2098150, 563994 and 2395160.



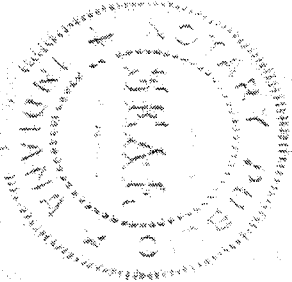
