
IT IS THEREFORE ORDERED, by the Commissioner of Insurance:

1. Respondent failed to disclose an administrative action taken by the state of Ohio in his application for a non-resident producer’s license.
2. After receiving a non-resident producer’s license in the state of Indiana,

Respondent failed to disclose that his application for non-resident producer's licenses were denied in the states of Colorado and Oklahoma.

3. Respondent failed to disclose that he was subject to an administrative action in Florida.
4. Respondent's resident producer's license 2382710 shall be permanently revoked, effective immediately.

AGREED ENTRY

This Agreed Entry is executed by Nikolas P. Mann, Attorney for and on behalf of the State of Indiana, Indiana Department of Insurance (“Department”), and Brad Wessler (“Respondent”), a non-resident insurance producer licensed in the State of Indiana, to resolve all issues in the above cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Executive Director / Acting Commissioner, Indiana Department of Insurance.

WHEREAS, Respondent is a non-resident insurance producer in the State of Indiana, holding license number 699607; and,

WHEREAS, Respondent applied for said license on April 5, 2010; and,

WHEREAS, Respondent answered “yes” to the question on the license application asking whether or not applicant had been subject to administrative action in other states or jurisdictions; and,

WHEREAS, Respondent disclosed that he had been a Respondent on an Order to Cease and Desist engaging in the sale of unauthorized insurance in the State of Utah in May, 2008; and,

WHEREAS, Respondent disclosed that he had been a Respondent on an Order to Cease and Desist engaging in the sale of unauthorized insurance in the State of Colorado in October, 2008; and,

WHEREAS, Respondent disclosed that he had been a Respondent on an Order to Cease and Desist engaging in the sale of unauthorized insurance in the State of Delaware in November, 2008; and,

WHEREAS, Respondent disclosed that he had been a Respondent on an Order to Cease and Desist engaging in the sale of unauthorized insurance in the State of Montana in May, 2009; and,

WHEREAS, Respondent disclosed that he had been a Respondent on an Order to Cease and Desist engaging in the sale of unauthorized insurance in the State of Maryland in June, 2009; and,

WHEREAS, Respondent disclosed that he had been a Respondent on an Order to Cease and Desist engaging in the sale of unauthorized insurance in the State of Washington in September, 2009; and

WHEREAS, Respondent, however, failed to disclose that he was a Respondent on an Order to Cease and Desist in the State of Ohio in February, 2010, in violation of Indiana Code § 27-1-15.6-12 (b) (1); and,

WHEREAS, Respondent failed to disclose that his application for a produce's license had been denied by the State of Colorado in May, 2010, in violation of Indiana Code § 27-1-15.6-17 (a); and,

WHEREAS, Respondent failed to disclose that he had signed a Consent Order with the State of Florida in May, 2010, in violation of Indiana Code § 27-1-15.6-17 (a); and,


WHEREAS, Respondent failed to disclose that his application for a producer's license had been denied by the State of Oklahoma in June, 2010, in violation of Indiana Code § 27-1-15.6-17 (a); and,

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without the necessity of a hearing;

IT IS THEREFORE NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives the right to a public hearing.
4. Respondent voluntarily and freely waives the right to judicial review of this matter.
5. Respondent's non-resident producer's license 699607 shall be immediately and permanently revoked.

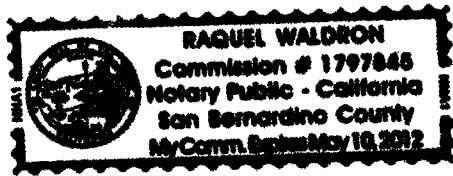
