

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without the necessity of a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:


1. The Acting Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives the right to a public hearing.
4. Respondent voluntarily and freely waives the right to judicial review of this matter.
5. The Respondent agrees to a **Permanent Revocation** of his Indiana insurance license number 412985 as **Permanent Revocation** is defined under Indiana Code 27-1-15.6-12 (a) (1) and (2).
6. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.
7. Respondent has carefully read this agreement and fully understands and accepts its terms.

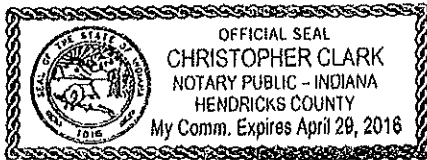
