On October 5, 2010, the Administrative Law Judge, filed his Findings of Fact, Conclusions of Law and Amended Recommended Order in the above-captioned matter.



Therefore, the Commissioner of Insurance, being fully advised, now hereby adopts in full the Administrative Law Judge's Findings of Fact, Conclusions of Law, and Recommended Order and issues the following Final Order:

IT IS THEREFORE ORDERED, by the Commissioner of Insurance:

1. Respondent's insurance producer license, number 565729, is permanently revoked.
2. Respondent shall pay a fine of five thousand dollars (\$5,000.00) for each of his forged applications, for a total of ten thousand dollars (\$10,000.00) in fines payable within sixty (60) days.

AMENDED RECOMMENDED ORDER


