

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. While being previously licensed by this Department as a Producer, Applicant failed to disclose an administrative action taken by the State of Washington.

2. Applicant will pay an administrative fine in the sum of \$250.00. The fine is payable within thirty (30) days of this Final Order.
3. Upon receipt of the payment of the fine, Applicant's producer's license application will be approved.

AGREED ENTRY

This Agreed Entry is executed by Nikolas P. Mann, Attorney for and on behalf of the State of Indiana, Indiana Department of Insurance ("Department"), and Joni Varnadoe, an applicant for a non-resident producer license in the State of Indiana, ("Applicant") to resolve all issues in the above cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, on September 29, 2010, the Department received an application for a non-resident producer's license from Applicant; and,

WHEREAS, on October 1, 2010, the Department received an amendment to the application wherein applicant disclosed that her producer's license had been revoked by the State of Washington in 2004 for failing to respond to a request to submit fingerprints; and,

WHEREAS, Applicant had previously held Indiana non-resident producer's license number 433075 from February 14, 2003 until February 28, 2007; and,

WHEREAS, while holding license number 433075; applicant failed to disclose that her producer's license had been revoked by the State of Washington in violation of Indiana Code § 27-1-15.6-17(a); and,


WHEREAS, the Department and Applicant desire to resolve their differences and settle the issues without the necessity of a hearing;

IT IS THEREFORE NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and the Applicant in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Applicant voluntarily and freely waives the right to a public hearing.
4. Applicant voluntarily and freely waives the right to judicial review of this matter.
5. Applicant shall pay a civil penalty in the amount of \$250.00. Payment shall be made to the State of Indiana, and will be due within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
6. Upon receipt of the \$250.00 civil penalty mentioned in paragraph 5, application 232129 will be accepted, and a non-resident producer's license will be issued to Applicant.
7. Applicant has carefully read this agreement and fully understands and accepts its terms.

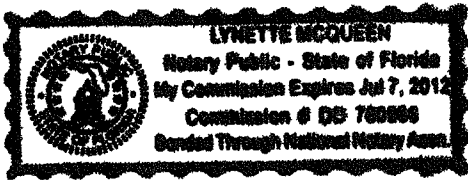
