FINAL ORDER AND APPROVAL

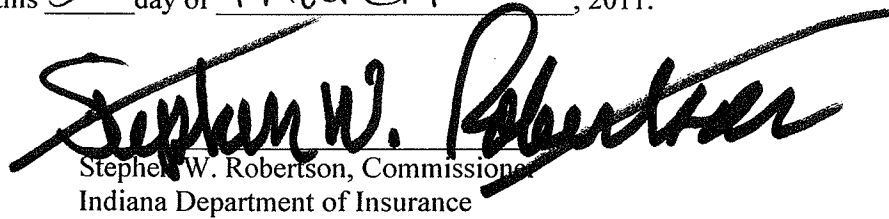

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent shall pay a civil penalty in the amount of six thousand dollars (\$6,000.00) within thirty (30) days front he date this Final Order is filed.

AGREED ENTRY

This Agreed Entry is executed by Laura A. W. Levenhagen, Attorney for and on behalf of the Indiana Department of Insurance (“Department”), and Trustworthy Land Title Co. Inc., Raymond L. Summeier, President and CEO, (“Respondent”), a resident title insurance agency, to resolve all issues in the above captioned matter. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance (the “Commissioner”).

WHEREAS, Respondent is a resident title insurance agency in the State of Indiana, holding producer license number 506063; and

WHEREAS, on or about March 1, 2010 Respondent employed an unlicensed individual, Anthony Gray (“Gray”), as a title insurance agent; and

WHEREAS, Although Gray represented to Respondent that he was a licensed agent, Respondent did not receive a copy of Gray's alleged license and made no efforts to verify that he was a licensed agent; and

WHEREAS, Respondent allowed Gray to sell, solicit and negotiate insurance in this state without being licensed to do so; and

WHEREAS, Respondent paid commissions to Gray for the sale of insurance without his being licensed; and

WHEREAS, The Department alleges that Respondent's actions violate Indiana Code § 27-1-15.6-3(a); and

WHEREAS, The Department alleges that Respondent's actions violate Indiana Code § 27-1-15.6-13(a); and

WHEREAS, The Department alleges that Respondent's actions demonstrate untrustworthiness and incompetence in the course of business under Indiana Code Section §27-1-15.6-12(b)(8).

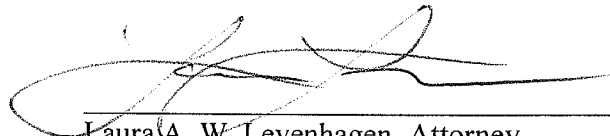
IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives the right to a public hearing in this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this matter.

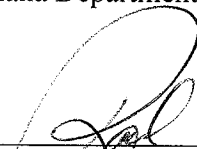
5. Respondent agrees to pay a civil penalty in the amount of six thousand dollars (\$6,000.00).
6. Respondent agrees that Raymond L. Summeier shall testify in the Department's administrative action against Anthony Gray, cause number 9392-AG10-1221-185.
7. The Department agrees to accept Respondent's compliance with the agreement herein as full satisfaction of this matter.
8. Respondent has carefully read and examined this agreement and fully understands its terms.
9. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.
10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
11. Respondent is aware that failure to comply with any term of this agreement will result in the matter being set for hearing.

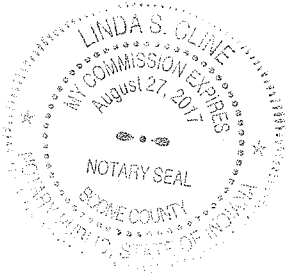
