FINAL ORDER AND APPROVAL



The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent agrees to the permanent surrender of his insurance producer license, effective on the date of this Final Order.
2. Respondent waives his right to petition for judicial review of this Final Order.

AGREED ENTRY

This Agreed Entry is executed by Robert L. Hummel, attorney for the Indiana Department of Insurance ("Department"), and Chad A. Huddleston ("Respondent"), formerly a licensed Indiana insurance producer, to resolve all issues concerning an investigation by the Department. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, Respondent was a licensed insurance producer in the State of Indiana, license number 397372, which expired on November 30, 2010; and

WHEREAS, on November 9, 2010, the Division sent Respondent a letter to his address of record in Indianapolis, Indiana concerning a child support arrearage; and

WHEREAS, the November 9, 2010 letter was returned to the Division by the U.S. Postal Service marked "return to sender, not deliverable as addressed, unable to forward"; and

WHEREAS, on November 17, 2010, the Division obtained an updated address in Seymour, Indiana for Respondent from the Department of Child Services; and

WHEREAS, on November 17, 2010, a Change of Address Violation letter was sent along with the November 9, 2010 letter via certified mail to Respondent stating that he had failed to notify the Department of his change of address and imposing a fine of one hundred dollars (\$100.00) payable within ten (10) business days after receipt by Respondent; and

WHEREAS, the November 17, 2010 certified letter was delivered and signed for on November 19, 2010; and

WHEREAS, after Respondent did not reply to the November 17, 2010 letter, a Statement of Charges and Notice of Hearing were filed on January 5, 2011, setting a hearing date for February 3, 2011 on the charge of failing to notify the Department of his change of address; and

WHEREAS, the parties conversed prior to the hearing date for the purpose of negotiating a settlement of the issues that have arisen; and

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS THEREFORE, NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and the Respondent in this investigation commenced on or about November 9, 2010.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives his right to a public hearing on the issues in this investigation.
4. Respondent admits that failing to notify the Department of his change of address within thirty (30) days is a violation of Indiana insurance law.

5. Respondent agrees to the permanent surrender of his insurance producer license, effective on the date the Commissioner signs the Final Order.
6. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues in the investigation commenced on or about November 9, 2010.
7. Respondent voluntarily and freely waives his right to petition for judicial review of this agreement and the Commissioner's Final Order.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
9. Respondent has carefully read this agreement and fully understands and accepts its terms.

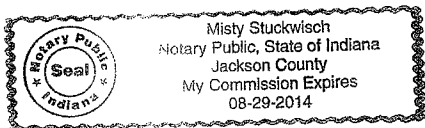
