ADMINISTRATIVE ORDER
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to the Indiana Administrative Act, Indiana Code 4-21.5-1 et seq. and Indiana Code § 27-1-15.6-12, hereby gives notice to Douglas Deerberg, (“Respondent”) of the following Administrative Order:

1. Indiana Code § 27-1-15.6-12(b) provides that “The commissioner may levy a civil penalty, place an insurance producer on probation, suspend an insurance producer’s license, revoke and insurance producer’s license for a period of years, permanently revoke an insurance producer’s license, or refuse to issue or renew an insurance producer license, or take any combination of these actions, ...”

2. Indiana Code § 27-1-15.6-12(d) provides that when the Commissioner refuses to renew a license, the Commissioner shall notify the Respondent, in writing, of the reasons for the nonrenewal.

3. Respondent, a resident of Indiana, held producer's license number 535180 until it was suspended under cause number 6869-AG08-0602-148 on July 3, 2008 for failure to pay child support.

4. On December 13, 2010 the Department received a complaint from Connie Crim relating to the sale of life insurance products to her by Respondent.

5. The Department sent a copy of Ms. Crim's complaint to Respondent by certified mail and requested a response to the complaint as well as a list of any company appointments held by Respondent under the authority granted by Indiana Code § 27-1-15.6-12(g).

6. Respondent signed for receipt of the Department's letter on January 13, 2011.

7. Respondent has failed to respond in any fashion to the Department.


8. Respondent's conduct, as alleged herein, is cause for disciplinary action in accordance with Indiana Code § 27-1-15.6-12(b)(8) and § 27-1-15.6-12(g).

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **Respondent's license shall not be renewed.**

WHEREFORE, the Commissioner further notifies Respondent that pursuant to Indiana Code §27-1-15.6-12(d), within sixty (60) days of receiving this Notice, Respondent may make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.
