

1. Respondent will pay an administrative fine in the amount of One Thousand Dollars (\$1,000.00). This amount is payable within thirty (30) days of this Final Order.

2. The Department agrees to accept Respondent's compliance with the terms of this agreement as full and final resolution of this matter.

This Agreed Entry is executed by Nikolas P. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, Respondent is an insurance company with a statutory home office located in the State of Illinois and licensed to do business in the State of Indiana; and

WHEREAS, Respondent was the subject of a complaint by an Indiana consumer regarding the handling of a claim under a liability insurance policy; and


WHEREAS, the Department and Respondent desire to resolve their differences and settle their issues without incurring the time and expense of a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives the right to a public hearing in this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this matter.
5. The Department alleges that Respondent failed to act reasonably promptly upon communications with respect to a claim arising under an insurance policy in violation of Indiana Code §27-4-1-4.5(2).
6. Respondent denies any wrongdoing.
7. Respondent agrees to pay an administrative fine in the amount of one thousand dollars (\$1,000.00) within thirty (30) days of the filing of the Commissioner's Final Order.
8. The Department agrees to accept Respondent's compliance with the terms of this agreement as full and final resolution of the complaint.
9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

10. Respondent has carefully read and examined this agreement and fully understands its terms.
