## **FINAL ORDER**

- 2. Respondent used fraudulent, coercive, or dishonest practices, or demonstrated incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana in violation of Indiana Code 27-1-15.6-12(b)(8).
- 3. Respondent will immediately Cease and Desist from selling, soliciting or negotiating insurance.
- 4. Respondent's producer license will be permanently revoked thirty (30) days after the signing of the Commissioner's Final Order. The delay in revocation is, solely for the purpose of facilitating the sale or transfer of his agency.
- 5. Respondent will no longer serve as the Qualifying Active Officer of Final Expense Services LLC., following the revocation of his producer license.
- 6. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's producer license.

- 7. Respondent will immediately Cease and Desist from selling, soliciting or negotiating insurance.
- 8. Respondent's producer license will be permanently revoked thirty (30) days after the signing of the Commissioner's Final Order. The delay in revocation is, solely for the purpose of facilitating the sale or transfer of his agency.
- 9. Respondent will no longer serve as the Qualifying Active Officer of Final Expense Services LLC., following the revocation of his producer license.

- 10. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's producer license.
- 11. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
