The Indiana Department of Insurance (“Department”) and Michael A. Lange, an applicant for an Indiana non-resident insurance producer license, signed an Agreed Entry which purports to resolve all issues involved in the action by the Department regarding Respondent’s producer license application, and which has been submitted to the Commissioner of Insurance (the “Commissioner”) for approval.

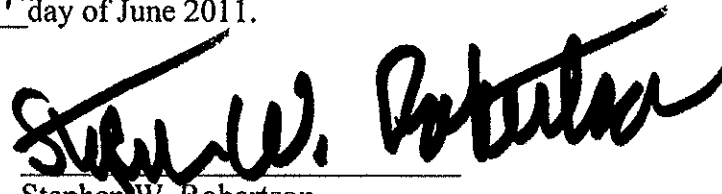
The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth as attached as Exhibit A herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent failed to disclosed an Administrative Action in Illinois on January 6, 2006, on his application for an Indiana non-resident producer license, in violation of Indiana Code 27-1-15.6-12(b)(1).

2. Respondent will pay an Administrative Fine of Two Hundred and Fifty Dollars (\$250.00) within Thirty (30) days of the Commissioner's Final Order.
3. Upon receipt of the Administrative Fine payment, Respondent's Producer License Application will be processed in the normal manner.
4. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's producer license application.

AGREED ENTRY

This Agreed Entry is executed by Nikolas P. Mann, Attorney for and on behalf of the State of Indiana, Department of Insurance ("Department"), and Michael A. Lange (Respondent), an applicant for a non-resident insurance producer license. This Agreed Entry is subject to the review and approval of the Commissioner of the Indiana Department of Insurance.

WHEREAS, Respondent is a resident of Illinois; and,

WHEREAS, Respondent holds a Resident Insurance Producer License in Illinois;
and,

WHEREAS, Respondent applied for an Indiana Non-Resident Producer License on April 27, 2011; and,

WHEREAS, Respondent failed to disclosed an Administrative Action in Illinois on January 6, 2006, on his application; and,

WHEREAS, the Department and Respondent desire to settle the issues without a hearing;

IT IS THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter of and the parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives his right to a public hearing.
4. Respondent voluntarily and freely waives his right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Respondent failed to disclosed an Administrative Action in Illinois on January 6, 2006, on his application in violation of Indiana Code 27-1-15.6-12(b)(1).
6. Respondent will pay an Administrative Fine of Two Hundred and Fifty Dollars (\$250.00) within Thirty (30) days of the Commissioner's Final Order.
7. Upon receipt of the Administrative Fine payment, Respondent's Producer License Application will be processed in the normal manner.
8. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's producer license application.
9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

10. Respondent has carefully read and examined this agreement and fully understands its terms.

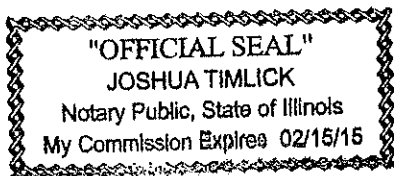
