FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, on May 25, 2011, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Aurora Insurance Agency, LLC ("Respondent") a certified letter requesting a list of company appointments;

WHEREAS, on May 27, 2011, certified mail article # 7005 3110 0002 4444 3954, was delivered by the US Postal Service to the Respondent.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as requested by the Commissioner;

WHEREAS, Respondent's failure to provide said list constitutes a violation of IC 27-1-15.6-12(g);

WHEREAS, the Commissioner has the authority to issue an order suspending Respondent's license without a hearing pending receipt of said list of appointments pursuant to IC 27-1-15.6-12(g);

WHEREAS, the Commissioner shall set this matter for hearing upon request of Respondent pursuant to IC 4-21.5-4-4;

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 35644 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments and response requested by the Commissioner.

ORDER GRANTING EMERGENCY CEASE AND DESIST ORDER

The Commissioner of the Indiana Department of Insurance ("Commissioner"), having reviewed the Enforcement Division's Motion for Emergency Cease and Desist Order, and being otherwise duly advised, now finds as follows:

FINDINGS OF FACT

- 1. The Department of Insurance ("Department") is authorized to regulate the practice of insurers in Indiana under Indiana Code 27-1 et seq.
- 2. The Department may hold disciplinary hearings in accordance with Indiana Code 4-21.5-3 and 4.
- 3. Respondent Debra Sajek-Devine has not held a valid producer's license since March 31, 2008.

- 4. Respondent Debra Sajek-Devine is listed as the sole principal producer of Respondent Aurora Insurance Agency, LLC in Department records.
- 5. Respondent Aurora Insurance Agency does not have a designated individual licensed as a producer and responsible for the business entity's compliance with the insurance laws and administrative rules of Indiana as required by Indiana Code § 27-1-15.6-6(d)(2).
- 6. Respondents have failed to provide a response to Niko Gardikiotes' complaint of misappropriation of premiums totaling approximately \$18,000 and have failed to provide a list of appointments to the Commissioner as required by Indiana Code § 27-1-15.6-12(g).

CONCLUSIONS OF LAW

- 1. An emergency exists in that Respondents continue to act as an insurance producer in the State of Indiana without proper licensure.
- 2. In an emergency, the Commissioner may issue appropriate orders without notice or an evidentiary proceeding under Indiana Code 4-21.5-4-2(a).

<u>ORDER</u>

It is, therefore, ORDERED, that Respondents must CEASE AND DESIST from acting as an insurance producer, from holding themselves out as such, or otherwise transacting insurance business in Indiana, or otherwise violating in any way the insurance laws of Indiana.

Pursuant to Indiana Code 4-21.5-4-2, this order remains effective for 90 days commencing on the date this order is issued.

Respondents are hereby notified of their right to a hearing concerning this order as quickly as practicable under Indiana Code 4-21.5-4-4.
