WHEREAS, during the course of a Desk Audit of Respondents' business practices it was discovered that both Respondents had been subject to a number of administrative actions in other states; and

WHEREAS, an investigation revealed these actions had not been reported to the Department within the statutorily required time; and

WHEREAS, the Department alleges that Respondents actions are a failure to report administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter and a violation of IC 27-1-15.6-17(a); and

WHEREAS, Mark S. Walker is authorized to act on behalf of the agency and obligate it to perform in accordance with this agreement; and

WHEREAS, the Department and Respondents desire to resolve their differences and settle the issues without a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and the Respondents in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondents knowingly, voluntarily and freely waive their right to a public hearing on the issues in this action.
- 4. Respondents waive their right to judicial review of this matter.
- 5. Respondents acknowledge that failing to report administrative action taken against it in another state is a violation of IC 27-1-15.6-17.
- 6. Respondents agree to the permanent revocation of their Indiana insurance producer licenses.
- 7. The Department agrees to accept Respondents' compliance with the terms of this Agreed Entry as full resolution of this matter.
- 8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall

not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

WHEREAS, the Commissioner shall set this matter for hearing upon request of Respondent pursuant to IC 4-21.5-4-4.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 35478 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of company appointments and documents relative to a non-resident desk audit.
