**FINAL ORDER**

The Indiana Department of Insurance (“Department”) and Roxena Burton, (“Applicant”), an applicant for a resident producer’s license, signed an Agreed Entry which purports to resolve all issues involved in the action by the Department regarding Respondent’s application, and which has been submitted to the Commissioner of Insurance (the “Commissioner”) for approval.


The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. While previously licensed by this Department as a Producer, Applicant’s producer’s license number 2277270 was suspended on April 26, 2001 for failing to report continuing education courses.

2. Applicant failed to report this administrative action on her application for a producer's license in March, 2011.
3. Applicant shall pay an administrative fine in the sum of \$500.00. The fine is payable within thirty (30) days of this Final Order.
4. Upon receipt of the payment of the fine, Applicant's producer's license application will be approved.

**AGREED ENTRY**

This Agreed Entry is executed by Nikolas P. Mann, Attorney for and on behalf of the State of Indiana, Indiana Department of Insurance ("Department"), and Roxena Burton, an applicant for a producer license in the State of Indiana ("Applicant") to resolve all issues in the above cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, on March 10, 2011, the Department received an application for a resident producer's license from Applicant; and,

WHEREAS, Applicant previously held producer's license number 2277270 from November 13, 1992 until it was suspended for failing to report continuing education courses on April 26, 2001; and,

WHEREAS, Applicant did not disclose this administrative action on her application for a producer's license in 2011; and,

WHEREAS, Applicant has told an investigator from the Department that she had ceased working in a capacity to use her license in 2001, and had disregarded letters from the Department regarding her continuing education requirements; and,

WHEREAS, Applicant wishes to resume working in a capacity requiring licensure, and understands the necessity of complying with Indiana laws; and,


WHEREAS, the Department and Applicant desire to resolve their differences and settle the issues without the necessity of a hearing;

IT IS THEREFORE NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and the Applicant in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Applicant voluntarily and freely waives the right to a public hearing.
4. Applicant voluntarily and freely waives the right to judicial review of this matter.
5. Applicant shall pay a civil penalty in the amount of \$500.00. Payment shall be made to the State of Indiana, and will be due within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
6. Upon receipt of the \$500.00 civil penalty mentioned in paragraph 5, application 247866 will be accepted, and resident producer's license will be issued to Applicant.
7. Applicant has carefully read this agreement and fully understands and accepts its terms.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall

not unfairly or illegally prejudice the Commissioner from further participation in  
or resolution of these proceedings.
