2. Respondent shall pay an administrative fine of \$500.00, payable to the State of

Indiana, within thirty (30) days of the filing of this Final Order.

WHEREAS, on May 11, 2011, the Department received an application for a non-resident producer's license from Applicant; and,


WHEREAS, Applicant failed to disclose administrative actions taken by the States of South Dakota in 1992 and Arizona in 1994 in violation of Indiana Code § 27-1-15.6-12(b)(1); and,

WHEREAS, the Department and Applicant desire to resolve their differences and settle the issues without the necessity of a hearing;

IT IS THEREFORE NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and the Applicant in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Applicant voluntarily and freely waives the right to a public hearing.
4. Applicant voluntarily and freely waives the right to judicial review of this matter.
5. Applicant shall pay a civil penalty in the amount of \$500.00. Payment shall be made to the State of Indiana, and will be due within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
6. Upon receipt of the \$500.00 civil penalty mentioned in paragraph 5, application 253201 will be accepted, and a non-resident producer's license will be issued to Applicant.
7. Applicant has carefully read this agreement and fully understands and accepts its terms.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
