**FINAL ORDER**

The Indiana Department of Insurance (“Department”) and Charles Darrigrand, (“Applicant”), an applicant for a resident producer’s license, signed an Agreed Entry which purports to resolve all issues involved in the action by the Department regarding Respondent’s application, and which has been submitted to the Commissioner of Insurance (the “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.


IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Applicant failed to provide his semi-annual tax report due August 1, 2005 while previously holding producer’s license 437544 and surplus lines license number

440140, in violation of Indiana Code § 27-1-15.8-4(c).

2. Applicant shall pay an administrative fine in the sum of \$500.00. The fine is payable within thirty (30) days of this Final Order.
3. Upon receipt of the payment of the fine, Applicant's producer's license application number 253924 will be approved.

**AGREED ENTRY**

This Agreed Entry is executed by Nikolas P. Mann, Attorney for and on behalf of the State of Indiana, Indiana Department of Insurance ("Department"), and Charles Darrigrand, an applicant for a non-resident producer license in the State of Indiana ("Applicant") to resolve all issues in the above cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, on May 23, 2011, the Department received an application for a non-resident producer's license from Applicant; and,

WHEREAS, Applicant previously held producer's license number 437544 and surplus lines license number 440140; and,


WHEREAS, Applicant, while holding a surplus lines license, failed to provide his semi-annual tax report due August 1, 2005 as required by Indiana Code 27-1-15.8-4(c); and,

WHEREAS, Applicant had been notified several times during 2006 that his semi-annual tax report was required and failure to provide it would result in disciplinary action; and,


IT IS THEREFORE NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Applicant in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Applicant voluntarily and freely waives the right to a public hearing.
4. Applicant voluntarily and freely waives the right to judicial review of this matter.
5. Applicant shall pay a civil penalty in the amount of \$500.00. Payment shall be made to the State of Indiana, and will be due within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
6. Upon receipt of the \$500.00 civil penalty mentioned in paragraph 5, application 253924 will be accepted, and a non-resident producer's license will be issued to Applicant.
7. Applicant has carefully read this agreement and fully understands and accepts its terms.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
