**FINAL ORDER**

The Indiana Department of Insurance (“Department”) and Enrique Guajardo, Sr., (“Respondent”), a licensed resident Indiana insurance producer, signed an Agreed Entry which purports to resolve all issues involved in the action by the Department regarding Respondent’s license, and which has been submitted to the Commissioner of Insurance (the “Commissioner”) for approval.


The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent shall pay an administrative penalty in the amount of two hundred fifty dollars (\$250.00), payable within sixty (60) days from the date of this Final Order.

2. Respondent's Indiana insurance producer's license shall be placed on probation for a period of twelve (12) months under the terms set forth in the Agreed Entry for this matter.

**AGREED ENTRY**

This Agreed Entry is entered into by Nikolas P. Mann, Attorney for and on behalf of the State of Indiana, Department of Insurance ("Department"), and Enrique Guajardo, Sr., ("Respondent"), a licensed Indiana resident insurance producer, to resolve all matters in the administrative action commenced by the Department. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner for the Indiana Department of Insurance.

WHEREAS, Respondent Enrique Guajardo, Sr. is a licensed resident insurance producer in the State of Indiana, holding license number 2883200 and,

WHEREAS, the Department received notice from Combined Insurance Company of America that Respondent had been terminated for submitting insurance documents containing forged signatures.

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without the necessity of an administrative hearing.

IT IS THEREFORE NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Respondent in this administrative action.

2. This Agreed Entry is executed voluntarily by the parties. Respondent voluntarily and freely waives his right to a public hearing on this matter.

3. Respondent voluntarily and freely waives his right to petition for judicial review of this agreement and the Commissioner's Final Order.

4. Respondent agrees to pay an administrative penalty in the amount of two hundred fifty dollars (\$250.00), due within sixty (60) days from the date the Commissioner signs the Final Order in this matter.

5. Respondent agrees to a probationary period of twelve (12) months wherein Respondent does not violate Indiana insurance law; and that he pays the administrative penalty as set forth in this Agreed Entry.

6. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.


7. Respondent is aware that failure to comply with any terms of this agreement will result in the matter being set for hearing.



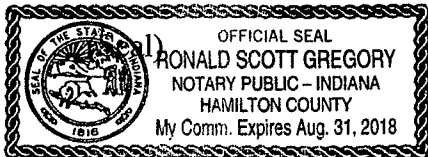
