
IT IS, THEREFORE, ORDERED, by the Commissioner of Insurance:

AGREED ENTRY

This Agreed Entry is executed by Nikolas P. Mann, Attorney for and on behalf of the State of Indiana, Department of Insurance ("Department"), and Steven Lovell ("Applicant"), an applicant for a non-resident producer's license, to resolve all matters in the above cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, on or around December 12, 2011, Applicant applied for a non-resident producer's license; and,

WHEREAS, Applicant answered "no" to the question regarding whether or not he had ever been subject to an administrative action; and,

WHEREAS, on November 29, 2007, Applicant was subject to an administrative action in the State of Georgia; and,

WHEREAS, Applicant states that it was an oversight which led to him providing incorrect, misleading, incomplete or materially untrue information in his license application, in violation of Indiana Code § 27-1-15.6-12 (b)(1); and,


WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS THEREFORE NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and the Applicant in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Applicant voluntarily and freely waives the right to a public hearing.
4. Applicant voluntarily and freely waives the right to judicial review of this matter.
5. Applicant shall pay a civil penalty in the amount of \$250.00. Payment shall be made to the State of Indiana, and will be due within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
6. Upon receipt of the \$250.00 civil penalty mentioned in paragraph 5, application 289996 will be accepted, and a non-resident producer's license will be issued to Applicant.
7. Applicant has carefully read this agreement and fully understands and accepts its terms.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the

Commissioner shall not unfairly or illegally prejudice the Commissioner
from further participation in or resolution of these proceedings.
