AGREED ENTRY

This Agreed Entry is executed by Robert L. Hummel, attorney for the Indiana Department of Insurance Bail Bond Division ("Division"), and Jennifer L. Brugger ("Applicant"), an applicant for an Indiana bail agent license, to resolve all issues concerning an investigation by the Division. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, Applicant applied for a bail agent license on December 29, 2011; and

WHEREAS, on the application, Applicant answered "yes" to the question, "Has a disciplinary action been taken against you by any public authority (law enforcement agency, Bureau of Motor Vehicles, etc.)?"; and

WHEREAS, Applicant attached an explanation of her "yes" answer stating that she was arrested in 2009 and charged with theft, a Class D felony, but the case was dismissed after a pre trial diversion agreement. She also stated that she received a speeding ticket on October 22, 2011 which she paid; and

WHEREAS, an investigation by the Division found that Applicant's Indiana driver's license had been suspended on seven (7) occasions from 1993 to 2003 and Applicant did not disclose that information on her bail agent license application; and

WHEREAS, the parties held a conference on January 20, 2012 for the purpose of negotiating a settlement of the issues that have arisen; and

WHEREAS, Applicant's prospective employer, bail agent Cheryl Fortune, was present at the conference and supported issuing Applicant a bail agent license; and

WHEREAS, per a request by the Division, subsequent to the conference, Applicant submitted twelve (12) letters of recommendation and evidence of awards received; and

WHEREAS, the Department and Applicant desire to resolve their differences and settle the issues without a hearing;

IT IS THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and Applicant in this investigation commenced on or about January 4, 2012.
- 2. This Agreed Entry is executed voluntarily by the parties.
- Applicant voluntarily and freely waives her right to a public hearing on the issues in this investigation.
- 4. Applicant admits that by not disclosing information about the suspensions of her driver's license, she did not properly answer a question on the bail agent license application.
- 5. The Department agrees to grant Applicant a bail agent license subject to a probationary period of one (1) year.

Applicant agrees that any violation of Indiana bail law during the 6. probationary period may, after an administrative hearing, result in the permanent revocation of her bail agent license and/or a civil penalty.

Applicant voluntarily and freely waives her right to petition for judicial 7. review of this agreement and the Commissioner's Final Order.

Should this Agreed Entry not be accepted by the Commissioner, it is 8. agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

Applicant has carefully read this agreement and fully understands and 9. accepts its terms.
