This Agreed Entry is entered into by Nikolas P. Mann, attorney for and on behalf of the State of Indiana, Department of Insurance ("Department"), and Sean William Thom ("Respondent"), an inactive licensed Indiana resident insurance producer that held license number 630131, to resolve all matters under Cause Number 10986-AG12-0209-014. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, Respondent was an active licensed resident insurance producer in the State of Indiana, with an original issue date of December 15, 2008. On December 31, 2010, Respondent's Indiana Resident Producer License became inactive for failure to renew; and

WHEREAS, on September 15, 1995, Respondent was convicted of an A Misdemeanor, Criminal Conversion, in Delaware County, Indiana, Circuit Court V, under Cause Number 18D04-9702-CM-33; and

WHEREAS, on March 30, 1999, Hamilton County, Indiana, Superior Court V accepted a guilty plea from the Respondent to Possession of Marijuana, a D Felony, under Cause Number 29D05-9807-DF-002513. Respondent was convicted and sentenced to three (3) years at the Indiana

Department of Correction, sixty (60) days ordered executed, and two (2) years three hundred five (305) days ordered suspended. On June 8, 2011, the Court modified Respondent's conviction from a D Felony to an A Misdemeanor; and

WHEREAS, on or about December 15, 2008, the Respondent submitted the application for his resident insurance producer license and answered "no" on the application question, "Have you ever been convicted of a crime, had a judgment withheld or deferred, or are you currently charged with committing a crime?" and

WHEREAS, on February 6, 2012, the Department received a Report of Investigation from Ben Lamb, an Investigator with AFLAC Insurance Company's Special Investigations Unit, stating that Respondent submitted paperwork establishing thirteen (13) businesses as AFLAC group accounts and each business was found to be fictitious. Investigator Lamb also stated that the Respondent submitted two hundred (200) applications for one hundred four (104) different individuals under these accounts and all of these individuals were also found to be fictitious; and

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives his right to a public hearing on the issues in this action.
- 4. Respondent provided incorrect and materially untrue information in a license application.

5. Respondent obtained a license through misrepresentation.

6. Respondent intentionally misrepresented the terms of proposed applications for

insurance.

7. Respondent agrees to the permanent revocation of his Indiana resident insurance

producer license number 630131.

8. The Department agrees to accept Respondent's compliance with the terms of this

Agreed Entry as full resolution of this matter.

9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed

that presentation to and consideration of this Agreed Entry by the Commissioner

shall not unfairly or illegally prejudice the Commissioner from further

participation in or resolution of these proceedings.

10. Respondent has carefully read this agreement and fully understands and accepts its

terms.
