FINAL ORDER

The Indiana Department of Insurance (“Department”) and Kim L. Keller, an Indiana resident insurance producer, signed an Agreed Entry which purports to resolve all issues involved in the action by the Department regarding Respondent’s license, and which has been submitted to the Commissioner of Insurance (the “Commissioner”) for approval.


The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth as attached as Exhibit A herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent submitted an application for an Indiana Resident Producer License on December 15, 2011. Respondent stated that she had no criminal convictions.

2. The Department received notification of the Respondent's termination for cause from the Respondent's employer, Horace Mann, in accordance with Indiana Code on February 22, 2012.
3. Respondent was convicted of Child Molesting, a Class C Felony, in the Carroll Circuit Court (Indiana) on November 1, 1984, under cause number S-84-22.
4. Respondent's Indiana Resident Producer is permanently revoked. If the Respondent applies for, and receives, a Governor's Pardon, the Respondent may reapply for a producer license. Respondent's license application will be considered in the normal manner.
5. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's producer license.

AGREED ENTRY

This Agreed Entry is executed by Nikolas P. Mann, Attorney for and on behalf of the State of Indiana, Department of Insurance (“Department”), and Kim L. Keller, a licensed resident insurance agent. This Agreed Entry is subject to the review and approval of the Commissioner of the Indiana Department of Insurance.

WHEREAS, Respondent is a resident of Indiana; and,

WHEREAS, Respondent holds Indiana Resident Insurance Producer license number 729258; and,

WHEREAS, Respondent failed to disclose a felony conviction on her application; for an Indiana Resident Insurance Producer License; and,

WHEREAS, the Department and Respondent desire to settle the issues without a hearing;

IT IS THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter of and the parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives her right to a public hearing.
4. Respondent voluntarily and freely waives her right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Respondent submitted an application for an Indiana Resident Producer License on December 15, 2011. Respondent stated that she had no criminal convictions.
6. The Department received notification of the Respondent's termination for cause from the Respondent's employer, Horace Mann, in accordance with Indiana Code on February 22, 2012.
7. Respondent was convicted of Child Molesting, a Class C Felony, in the Carroll Circuit Court (Indiana) on November 1, 1984, under cause number S-84-22.
8. Respondent's Indiana Resident Producer will be permanently revoked. If the Respondent applies for, and receives, a Governor's Pardon, the Respondent may reapply for a producer license. Respondent's license application will be considered in the normal manner.
9. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's producer license.
10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the

Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

11. Respondent has carefully read and examined this agreement and fully understands its terms.
