WHEREAS, on April 16, 2012 of the Indiana Department of Insurance ("Commissioner") mailed Rodger Lederer ("Respondent") a certified letter requesting a list of appointments and a written response to a complaint received by the Department.

WHEREAS, on April 27, 2012, the certified mail receipt for article # 7005 3110 0002 4442 8524, was returned signed by Respondent indicating receipt of the Commissioner's request.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as requested by the Commissioner.


WHEREAS, Respondent's failure to provide said list constitutes a violation of IC 27-1-15.6-12(g).

WHEREAS, the Commissioner has the authority to issue an order suspending Respondent's license without a hearing pending receipt of said list of appointments pursuant to IC 27-1-15.6-12(h).

WHEREAS, the Commissioner shall set this matter for hearing upon request of Respondent pursuant to IC 4-21.5-4-4.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 674007 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments and response requested by the Commissioner.
