
WHEREAS, the Department and Respondents desire to resolve their differences and settle the issues without the necessity of an administrative hearing.

ORDER GRANTING EMERGENCY CEASE AND DESIST ORDER

FINDINGS OF FACT

1. The Department of Insurance ("Department") is authorized to regulate the practice of insurers and producers in Indiana under Indiana Code 27-1 et seq.

- 2. The Department may hold disciplinary hearings in accordance with Indiana Code 4-21,5-3 and 4.
- 3. Respondent Rasmussen's license was suspended by Commissioner's Order on April 27, 2012 for failing to provide a list of appointments within ten (10) days as requested by the Commissioner.
- 4. The Department has discovered that Respondent Rasmussen continues to sell, solicit or negotiate insurance business at the offices of Respondent Norush without a valid license.
 - 5. Respondent Rasmussen has also admitted to failing to remit insurance premium.

CONCLUSIONS OF LAW

- 6. An emergency exists in that Respondents continue to sell, solicit or negotiate insurance in violation of Indiana Code 27-1-15.6-6.
- 7. An emergency further exists in that Respondent Rasmussen has failed to remit insurance premium. This constitutes the improper withholding, misappropriating, or converting of monies received in the course of doing insurance business and is cause for disciplinary action in accordance with Indiana Code 27-1-15.6-12(b)(4).
- 8. In an emergency, the Commissioner may issue appropriate orders without notice or an evidentiary proceeding under Indiana Code 4-21.5-4-2(a).

ORDER

It is, therefore, ORDERED, that Respondents must CEASE AND DESIST from selling, soliciting or negotiating insurance in Indiana, or otherwise violating in any way the insurance laws of Indiana.

It is further ORDERED that the office of Norush Insurance, Inc., located at 109 W. Mill Street, Attica, Indiana, be closed for business immediately.

Pursuant to Indiana Code 4-21.5-4-2, this order remains effective for 90 days commencing on the date this Order is issued.

Respondents are hereby notified of their right to a hearing concerning this Order as quickly as practicable under Indiana Code 4-21.5-4-4.

MOTION FOR EMERGENCY CEASE AND DESIST ORDER

The Enforcement Division of the Indiana Department of Insurance, pursuant to Indiana Code 4-21.5-4 and Indiana Code 27-1-15.6 et seq., files its Motion for an Emergency Cease and Desist Order against Norush Insurance, Inc. ("Respondent Norush" or "Norush agency") and Clarissa Rasmussen ("Respondent Rasmussen"), individually, and as owner of Respondent Norush (collectively "Respondents") and states:

- 1. Respondent Rasmussen is a licensed resident insurance producer holding license number 636067.
- 2. Respondent Norush, a licensed resident insurance producer agency holding license number 2587370, is owned and operated by Clarissa Rasmussen.

- 3: On or about December 1, 2009, Respondent Rasmussen purchased the Norush agency from Thomas Norush, a previously licensed resident insurance producer. Mr. Norush agreed to the permanent revocation of his insurance producer license on September 25, 2009 for failing to remit premium to an insurer.
- 4. Respondent Rasmussen was terminated for cause on February 24, 2012, by IHT Insurance Agency Group after she too admitted to failing to remit insurance premium.
- 5. On April 27, 2012, the Commissioner issued a Findings of Fact and Suspension Order for Respondent Rasmussen for failure to respond to the Commissioner's request for a response and a list of company appointments.
- 6. On May 10, 2012, Ronda Ankney, Investigator for the Enforcement Division, spoke with Respondent Rasmussen by placing a phone call to the Norush agency office. Ms. Ankney informed Respondent Rasmussen her producer license was currently suspended for failure to respond and that she was prohibited from selling, soliciting or negotiating insurance until the license was reinstated. Investigator Ankney followed up the conversation with a fax to Respondents that included the notice of termination, the Commissioner's request for information and the Suspension Order. As of the date of this conversation, at the very latest, there could be no misunderstanding on the part of Respondent Rasmussen that her license to sell, solicit and negotiate insurance was suspended.
- 7. To date, no additional information has been provided to the Department by Respondents and Respondent Rasmussen's producer license remains suspended.

8. On May 15, 2012, with the knowledge of and cooperation from the Attica Police Department, Cassandra Dillman of Attica, Indiana went to Respondent Norush and was provided

a quote for insurance coverage by Respondent Rasmussen.

9. An emergency exists in that Respondent Rasmussen continues to act as an

insurance producer without an active license and represents a danger to the insuring public.

Respondent Rasmussen is the only known insurance producer for Respondent Norush and has

sole authority to act on its behalf.

10. An emergency further exists in that the previous owner of Respondent Norush,

Thomas Norush, agreed to the permanent revocation of his insurance producer license on

September 25, 2009 for failing to remit premium to an insurer, thereby demonstrating a

continued pattern and practice in this agency, through two owners, of conduct in violation of

Indiana Insurance Code.

11. Under Indiana Code 4-21.5-4-2(a)(1), the Commissioner may, in an emergency,

issue orders without notice or an evidentiary proceeding. (Upon issuance of an emergency order,

the Respondent may request a hearing as quickly as practicable under Indiana Code 4-21.5-4-4).

WHEREFORE, the Enforcement Division requests that the Commissioner issue an

Emergency Cease and Desist Order against Respondents under Indiana Code 4-21.5-4-2, and for

all other necessary and proper relief.
