FINAL ORDER AND APPROVAL

The Indiana Department of Insurance ("Department"), by its counsel, Robert L. Hummel, and Warren R. George ("Respondent"), a licensed bail agent, signed an Agreed Entry which purports to resolve all issues involved in an investigation by the Bail Bond Division ("Division") and which has been submitted to the Commissioner of Insurance ("Commissioner") for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress, or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.


IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent shall pay a civil penalty in the amount of two hundred and fifty dollars (\$250.00), payable by personal check or money order to the

Department of Insurance Bail Bond Division, and due in full within thirty
(30) days after the date of this Final Order.

2. Respondent waives his right to petition for judicial review of this Final Order.

AGREED ENTRY

This Agreed Entry is executed by Robert L. Hummel, attorney for the Indiana Department of Insurance Bail Bond Division ("Division"), and Warren R. George ("Respondent"), a licensed Indiana bail bond agent, to resolve all issues concerning an investigation by the Division. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, Respondent is a licensed bail bond agent, license number 5249; and

WHEREAS, on April 24, 2012 the Division received a complaint from bail agent James Degan stating Respondent had parked his pick-up truck in the parking lot of the Hendricks County (Indiana) jail with a sign on the side of the truck advertising Respondent's bail bond business, Bail-N-Go, in violation of Indiana bail law; and

WHEREAS, the parties held a meeting on June 18, 2012 for the purpose of negotiating a settlement of the issue that has arisen; and

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Respondent in this investigation commenced on or about April 24, 2012.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives his right to a public hearing on the issues in this investigation.
4. Respondent admits that displaying advertising for his bail bond business on jail property was contrary to Indiana bail law.
5. Respondent agrees to payment of a civil penalty in the amount of two hundred and fifty dollars (\$250.00), payable by personal check or money order to the Department of Insurance Bail Bond Division, within thirty (30) days after the date the Commissioner issues his Final Order in this matter.
6. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues in the investigation commenced on or about April 24, 2012.
7. Respondent voluntarily and freely waives his right to petition for judicial review of this agreement and the Commissioner's Final Order.
8. Respondent is aware that his failure to comply with any of the terms of this agreement will result in the matter being set for hearing and may result in the permanent revocation of his bail bond license and/or additional civil penalties.
9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the

Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

10. Respondent has carefully read this agreement and fully understands and accepts its terms.

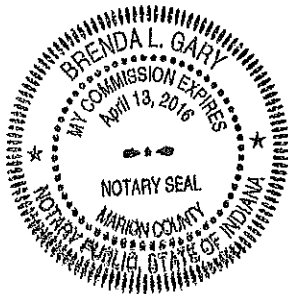
