The Indiana Department of Insurance (“Department”) and Charles R. Myers, a Texas resident applying for a non-resident producer’s license (“Applicant”), signed an Agreed Entry which purports to resolve all matters in the above referenced cause number, and which has been submitted to the Department’s Commissioner (“Commissioner”) for approval.


The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein and approves and adopts in full the Agreed Entry as a resolution of this matter.

**IT IS, THEREFORE, ORDERED** by the Commissioner:

1. Applicant shall pay a civil penalty of five hundred and 00/100 dollars (\$500.00), payable to the State of Indiana, within thirty (30) days of the date of this Final Order.
2. The Department shall issue a non-resident producer’s license to Applicant upon

receipt of Applicant's payment.

AGREED ENTRY

This Agreed Entry is executed by Nikolas P. Mann, Deputy Commissioner for and on behalf of the State of Indiana, Department of Insurance ("Department"), and Charles R. Myers ("Applicant"), an applicant for a non-resident producer's license, to resolve all matters in the above cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, on or around May 23, 2012, Applicant applied for a non-resident producer's license; and,

WHEREAS, Applicant answered "no" to the question regarding whether or not he had ever been subject to an administrative action; and,

WHEREAS, on May 18, 2006, Applicant was subject to an administrative action in the State of Texas; and,

WHEREAS, Applicant states that it was an oversight which led to him providing incorrect, misleading, incomplete or materially untrue information in his license application, in violation of Indiana Code § 27-1-15.6-12 (b)(1); and,


WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS THEREFORE NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Applicant in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Applicant voluntarily and freely waives the right to a public hearing.
4. Applicant voluntarily and freely waives the right to judicial review of this matter.
5. Applicant shall pay a civil penalty in the amount of five hundred dollars and 00/100 (\$500.00). Payment shall be made to the State of Indiana, and will be due within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
6. Upon receipt of the five hundred dollars and 00/100 (\$500.00) civil penalty mentioned in paragraph 5, application 317894 will be accepted, and a non-resident producer's license will be issued to Applicant.
7. Applicant has carefully read this agreement and fully understands and accepts its terms.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the

Commissioner shall not unfairly or illegally prejudice the Commissioner  
from further participation in or resolution of these proceedings.


