**FINAL ORDER**

The Indiana Department of Insurance (“Department”) and Taulbert J. Campbell, an Indiana resident applying for an insurance producer’s license (“Applicant”), signed an Agreed Entry which purports to resolve all matters in the above referenced cause number, and which has been submitted to the Department’s Commissioner (“Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein and approves and adopts in full the Agreed Entry as a resolution of this matter.

**IT IS, THEREFORE, ORDERED** by the Commissioner:

1. The Department hereby grants Applicant consent to engage in the business of insurance pursuant to 18 U.S.C. § 1033(e)(2) and issues Applicant his Indiana insurance producer’s license.

2. Applicant will be on probationary status for two years from the date of this Order..

**AGREED ENTRY**

This Agreed Entry is entered into by and between Adam H. Berry, attorney for and on behalf of the Indiana Department of Insurance (“Department”), and Taulbert J. Campbell (“Applicant”), an applicant for a resident producer’s license, to resolve all matters in the above referenced cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner for the Department (“Commissioner”).

WHEREAS, on or about June 11, 2012, Applicant applied for a resident producer’s license; and

WHEREAS, Applicant disclosed to the Department that, on or about September 16, 2004, the State of Indiana convicted him of two felonies: “Operating a Vehicle while Intoxicated with a Prior Conviction” and “Possession of a Controlled Substance”; and

WHEREAS, having been convicted of a felony is cause for the Commissioner to deny Applicant’s license application pursuant to IC § 27-1-15.6-12(b)(6); and


WHEREAS, the Department and Applicant desire to resolve their differences and settle the issues without a hearing.

**IT IS, THEREFORE, NOW AGREED** by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and Applicant in this administrative action.
2. This Agreed Entry is executed voluntarily by and between the parties.
3. Applicant voluntarily and freely waives the right to a public hearing on this matter.
4. Applicant voluntarily and freely waives his right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Applicant must complete an application for written consent to engage in the business of insurance pursuant to 18 U.S.C. §§ 1033 & 1034. Applicant must submit said application to the Department before the Commissioner will consider the adoption of this Agreed Entry.
6. The Department will give Applicant written consent to engage in the business of insurance pursuant to 18 U.S.C. § 1033(e)(2) contemporaneous with the issuance of Applicant's resident producer's license.
7. Applicant will be placed on probation for a period of two (2) years.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

9. Applicant has carefully read this agreement and fully understands and accepts its terms.
