

WHEREAS, on or around June 28, 2012, Applicant applied for a resident producer's license; and

WHEREAS, Applicant disclosed that he had been convicted of three (3) felonies in 2008; and

WHEREAS, Applicant's behavior, as alleged herein, is cause for denial of said license application pursuant to Ind. Code § 27-1-15.6-12 (b)(6); and


WHEREAS, the Department and Applicant desire to resolve their differences and settle the issues without a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and Applicant in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Applicant voluntarily and freely waives the right to a public hearing.
4. Applicant voluntarily and freely waives the right to judicial review of this matter.
5. Applicant's application for a producer's license shall be granted and immediately placed on probationary status for a period of one (1) year.
6. Applicant has carefully read this agreement and fully understands and accepts its terms.
7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
