Respondent's

individual producer's license had expired for approximately a period of three months before the examination date; and

WHEREAS, Respondent participated during employment with the agency in transactions involving title insurance and acted as an escrow closer during the time the license was expired; and

WHEREAS, Respondent has obtained the proper license having renewed and is currently practicing the business of selling, soliciting or negotiating title insurance in the State of Indiana; and

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;
