WHEREAS, during the course of an examination of Respondent's employer Dearborn Title Insurance, Inc., the senior examiner Fred Medley discovered that Respondent was selling, soliciting and negotiating title insurance while employed as an escrow closer by the agency without a current and valid license during a period from 8/31/2012 thru 10/14/2012.

Respondent's individual producer's license had expired for approximately a period of two months before the examination date; and

WHEREAS, Respondent participated during employment with the agency in at least three transactions involving title insurance and acted as an escrow closer during the time the license was expired; and

WHEREAS, Respondent has obtained the proper license having renewed with an effective date of 10/15/2012 and is currently practicing the business of selling, soliciting or negotiating title insurance in the State of Indiana; and

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Respondent in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives her right to a public hearing on the issues in this action.
- 4. Respondent waives her right for a judicial review of this matter.
- 5. Respondent has obtained the proper licensing after being unlicensed for the period of 8/31/2012 thru 10/14/2012.
- 6. Respondent agrees to pay a civil penalty of \$250.00 within thirty days (30) of the signing of the Commissioner's Final Order for non-compliance with the Indiana insurance producer licensing statutes.

- 7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
