**PRELIMINARY ADMINISTRATIVE ORDER**  
**AND NOTICE OF LICENSE DENIAL**

The Indiana Department of Insurance (“Department”), pursuant to the Indiana Administrative Orders and Procedures Act, Ind. Code 4-21.5-1 *et seq.*, and Ind. Code § 27-1-15.6-12, hereby gives notice to Ned L. Ryan (“Applicant”) that his application for a resident producer license is denied pursuant to the following Administrative Order:

1. Applicant filed an application for licensure with the Commissioner on or about February 13, 2013. Upon review of the documents and information Applicant submitted contemporaneous with his application, the Commissioner of the Department (“Commissioner”), being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure as stated by Ind. Code § 27-1-15.6-12(b); specifically, Applicant has a conviction for “Neglect of a Dependent”, a class D felony, and

2. Ind. Code § 27-1-15.6-12(d) provides, in part, as follows:


If the Commissioner refuses to renew a license or denies an application for a license, the Commissioner shall notify the applicant or licensee and advise the

applicant or licensee ... of the reason for the denial of the applicant's application or the non renewal of the licensee's license.

3. Applicant may, not more than sixty-three (63) days after the date this notice is mailed, make a written demand to the Commissioner for a hearing to determine the reasonableness of the Commissioner's action. The hearing will be held not more than thirty (30) days after Applicant's demand and will be conducted in accordance with Ind. Code 4-21.

**IT IS THEREFORE ORDERED** that Applicant's request for licensure is hereby denied pursuant to Indiana Code 27-1-15.6-12(b).
