FINAL ORDER

(2) Respondent agrees that the unlicensed employee will not sell, solicit or negotiate title insurance products or services including performing the function of a closing agent without first having obtained the proper license to do so in Indiana.

AGREED ENTRY

This Agreed Entry is entered into by Dan L. Oliver, Attorney for and on behalf of the State of Indiana, Department of Insurance ("Department"), and HLC Settlement Services, Inc., ("Respondent"), a licensed non-resident insurance producer firm holding Indiana insurance license number 696313, to resolve all matters under Cause Number 11971-CO13-0509-012. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, Respondent is currently a licensed non-resident insurance producer firm in the State of Indiana; and

WHEREAS, during the course of an examination of Respondent, the examiner Nicole Lotter discovered that Respondent employed an unlicensed escrow closing agent; and

WHEREAS, the agency benefited from the collection of premiums and closing fees resulting from transactions examined by the examiner during the time the employee was unlicensed in Indiana; and

WHEREAS, Craig Goodwin, as Director, Title is authorized to act on behalf of the agency and obligate it to perform in accordance with this agreement; and

WHEREAS, the employee has not obtained the proper license, and is not currently practicing the business of selling, soliciting or negotiating title insurance in the State of Indiana; and

WHEREAS, the parties desire to resolve their differences and settle the issues without a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and the Respondent in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives its right to a public hearing on the issues in this action.
- 4. Respondent waives its right for a judicial review of this matter.
- 5. Respondent agrees to pay a civil penalty of \$250.00 within thirty days (30) of the signing of the Commissioner's Final Order for non-compliance with the Indiana insurance producer licensing statutes.
- 6. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 7. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.
