PRELIMINARY ADMINISTRATIVE ORDER
AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance (“Department”), pursuant to the Indiana Administrative Orders and Procedures Act, Ind. Code § 4-21.5-1 *et seq.*, and Ind. Code § 27-1-15.6-12, hereby gives notice to **Ashley Nicole Picking** (“Applicant”) of the following Administrative Order:

1. Applicant filed an application for licensure with the Department on or around June 6, 2013. Following a review of materials submitted by Applicant in support of her application, and materials discovered during the Department’s investigation of Applicant, the Commissioner of the Department (“Commissioner”), being fully advised, now hereby notifies Applicant that she has not fully met the requirements of licensure as stated by Ind. Code § 27-1-15.6-12(b); specifically, Applicant has been convicted of one (1) felony count of theft..

2. Ind. Code § 27-1-15.6-12(d) provides, in part, as follows:


If the Commissioner refuses to renew a license or denies an application for a license, the Commissioner shall notify the applicant or licensee and advise the applicant or licensee, in a writing sent through regular first class mail, of the reason for the denial of the applicant’s application or the non renewal of the licensee’s license.

3. Applicant may, not more than sixty-three (63) days after this notice is mailed, make a written demand to the Commissioner for a hearing to determine the reasonableness of the Commissioner's action. The hearing will be held not more than thirty (30) days after Applicant's demand and will be conducted under Ind. Code 4-21.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby denied pursuant to Indiana Code 27-1-15.6-12(b).
