**ORDER GRANTING**  
**EMERGENCY CEASE AND DESIST ORDER**

The Commissioner of the Indiana Department of Insurance (“Commissioner”), having reviewed the Enforcement Division’s Motion for Emergency Cease and Desist Order, and being otherwise duly advised, now finds as follows:

**FINDINGS OF FACT**

1. The Department of Insurance (“Department”) is authorized to regulate the practice of Insurers and Public Adjusters in Indiana under Indiana Code § 27-1 et seq.;
2. The Department may hold disciplinary hearings in accordance with Indiana Code § 4-21.5-3 and 4;
3. Respondent Blue Point is not now, and never has been, licensed as a Public Adjuster in Indiana; and
4. The Department has discovered that Respondent Blue Point continues to act as a Public Adjuster in Indiana without a valid license.

### CONCLUSIONS OF LAW

5. An emergency exists in that Respondent continues to act as a Public Adjuster in violation of Indiana Code § 27-1-27-2; and
6. In an emergency, the Commissioner may issue appropriate orders without notice or an evidentiary proceeding under Indiana Code § 4-21.5-4-2(a).


### ORDER

It is, therefore, ORDERED, that Respondent must CEASE AND DESIST from acting as a Public Adjuster in Indiana, or otherwise violating in any way the insurance laws of Indiana.

Pursuant to Indiana Code § 4-21.5-4-2, this order remains effective for ninety (90) days commencing on the date this Order is issued.

Respondent is hereby notified of the right to a hearing concerning this Order as quickly as practicable under Indiana Code § 4-21.5-4-4.



**MOTION FOR EMERGENCY CEASE AND DESIST ORDER**

The Enforcement Division of the Indiana Department of Insurance, pursuant to Indiana Code § 4-21.5-4 and Indiana Code § 27-1-27 et seq., files its Motion for an Emergency Cease and Desist Order against Blue Point Adjusting & Loss Management Inc. ("Respondent Blue Point"), and states:

1. Respondent Blue Point is an Illinois resident Public Adjusting firm, and is licensed in that state under license number 100353647.
2. Respondent Blue Point is not licensed by the Indiana Department of Insurance as a Public Adjuster.
3. Respondent Blue Point is acting as a Public Adjuster in Indiana, and is representing Indiana consumers in insurance claims.

WHEREFORE, the Enforcement Division requests that the Commissioner issue an Emergency Cease and Desist Order against Respondent under Indiana Code § 4-21.5-4-2, and for all other necessary and proper relief.
