FINAL ORDER

The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Michael F. Mullen, and John C. Verbrugge (“Respondent”), a licensed resident insurance producer, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner as follows:

1. Respondent’s Indiana Resident Insurance Producer License, number 426647, is hereby permanently revoked.

2. The Department agrees to accept Verbrugge's compliance with the terms of this agreement as full resolution of the issue.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Michael F. Mullen, and John C. Verbrugge (“Respondent”), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of the Department’s Commissioner, Stephen W. Robertson.

WHEREAS, Respondent is a resident licensed insurance producer, holding license number 426647; and

WHEREAS, on or about March 20, 2013, Respondent was terminated from The Western Southern Life Insurance Company and Western Southern Life Assurance Company (“W&S”) after an internal audit investigation was completed; and

WHEREAS, W&S’s audit revealed that Respondent submitted eleven (11) applications with invalid social security numbers; two (2) insurance applications which were not signed by

the insured; and three (3) applications for which premium payments would be withdrawn from the Respondent's personal checking account; and

WHEREAS, Respondent's actions, as alleged herein, are in violation of Indiana Code §27-1-15.6-12(b)(8); and

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to settle these issues without a hearing.


IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and of the Respondent to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives his right to a public hearing on this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Respondent agrees to the Permanent Revocation of his Insurance Producer's License.
6. Respondent is aware that failure to comply with any term of this Agreed Entry will result in this matter being set for hearing.
7. Respondent understands that this Agreed Entry will result in a state action against his Indiana resident license, and Respondent may be required to report that action to other states where he holds or applies for professional licenses.

8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
9. Respondent has carefully read and examined this agreement and fully understands and accepts its terms.


